Cost of Tender:

The Tender Document will be issued in person against payment of Rs.100=00 drawn in favour of ICAR Unit – ATARI Account or Card Swipe Machine(Debit/Credit Card) which is non-refundable. The bidders who have downloaded from ICAR –ATARI website www.zpd5hyd.nic.in has to submit the tender cost of Rs.100=00 in the form of Demand Draft to be drawn in favour of ICAR Unit – ATARI Account (non-refundable) along with the tender document failing which the tender will not be accepted.

Bids should be accompanied with an EMD as per the items in the lot by means of Demand Draft/Banker's Cheque drawn in favour of "ICAR Unit : ATARI payable at Hyderabad from any national bank. Bids received without EMD shall not be considered and the party will not be allowed to take part in the auction. After withholding the EMD of first, second and third highest bidders, the unsuccessful bidders EMD will be returned after the auction.

If the rate offered by the bidders is not in the interest of the organization as prescribed, the material will be kept for open auction. If the successful bidder fails


to pay the full amount within three days, or the bidder fails to accept the bid, the EMD will be forfeited. One percent (1%) of the total value of the bidding amount will be charged extra per day towards storage charges in case the material is not removed from the Academy's premises within the stipulated period of three days from the date of auction by the successful bidder.

Interested bidders may inspect the auctioned goods of different lots on 12th and 14th September, 2018 during Office working hours and also obtain details of the items from the Stores Officer on any working day between 10.00 a.m. to 03.00 p.m. at ICAR-ATARI premises.

The last date for receipt of bids will be accepted upto 11.00 A.M. on 15th September, 2018 and the bids will be opened at 12.00 Noon on the same day. The bid(s) may be addressed to the Director, ICAR-ATARI, Hyderabad – 500 059. Please send your offer in sealed bids so as to reach this office on or before 10.00 A.M on 15th September, 2018. Late submission of bids and unsigned bids for the schedule shall not be entertained under any circumstances after specified date and time as indicated.

Interested bidders or their authorized representatives may be present at the time of opening the bids. The information format should invariably be filled in and duly signed by the authorized signatory of bid. The Director, ICAR-ATARI reserves the right to reject any bid without assigning any reason thereof. Decision of the Director will be final and legally binding. All disputes will be subject to Hyderabad jurisdiction only.
